RENEWAL OF INTERLOCAL AGREEMENT FOR FIRE PROTECTION, EMERGENCY MEDICAL AND RELATED SERVICES TO THE BRIGHTWATER TREATMENT PLANT

THIS RENEWAL (the "Renewal") of INTERLOCAL AGREEMENT (the "Agreement") is made and entered into this 3rd day of July, 2018, by and between **SNOHOMISH COUNTY FIRE PROTECTION DISTRICT NO. 7**, a municipal corporation (the "District") and **KING COUNTY**, a home rule charter county, a political subdivision of the State of Washington, (the "County"). County and District may be collectively referred to herein as the "Parties."

WHEREAS, the Parties executed an Interlocal Agreement for Fire Protection, Emergency Medical and Related Services to the Brightwater Treatment Plant (the "ILA") on July 31, 2013; and

WHEREAS, the Initial Term of the Agreement expires December 31, 2018 but is subject to renewal as provided in Section 2.1 of the ILA; and

WHEREAS, the Parties have mutually agreed to renew the ILA for a five year term as provided in the ILA.

NOW, THEREFORE, in consideration of the foregoing, and of the following terms and conditions, **IT IS MUTUALLY AGREED AS FOLLOWS:**

- 1. <u>Renewal</u>. The ILA is hereby renewed for an additional five (5) year term commencing on January 1, 2019 and terminating December 31, 2023 (the "First Renewal Term").
- 2. <u>Cost of Services and Payment.</u> Beginning January 1, 2019, the annual Cost of Service for the First Renewal Term shall be \$112,449.50. This amount is based on the methodology set forth in Exhibit A. This amount shall remain fixed and constant throughout the First Renewal Term.
- 3. <u>All Other Terms and Conditions</u>. The Parties agree, except as otherwise provided in this Renewal, that all other terms of the Agreement shall remain unchanged and unaltered, and that the Agreement is otherwise in full force and effect pursuant to the terms of the Agreement.

IN WITNESS WHEREOF, the District and the County have executed this Renewal as of the latter date of signature below.
