Chief's Report

October 12 - 20, 2022

Community Open House in Monroe

Thanks to everyone who helped SRFR host the Community Open House at Monroe Station 31 on Saturday, October 15. The event was a great success and very well attended! Kudos to our Public Information Officers Kaitlin King and Peter Mongillo for coordinating the event. Special thanks to the Mattern family for being Open House MVPs!

This Chief's Report below is a reprint of the October 12 Chief's Report.

OPERATIONS

Significant Alarms

Wildland Interface Fire

September 26, 2022, Monroe: SRFR units responded to a brush fire in the Monroe area north of the Skykomish River near the railroad tracks. Responders arrived to find a 30' X 30' fire involving grass, brush, and trees near a homeless encampment. The Burlington Northern rail line and the eastbound lanes of Hwy. 2 were closed to conduct firefighting operations. The fire was successfully extinguished with no injuries to civilians or responders. Assisting agencies included Snohomish County Fire District 4, the Department of Natural Resources, Washington State Patrol, and Monroe Police. The cause of the fire is under investigation by the Snohomish County Fire Marshal.

Brush Fire

September 22, 2022, 1:30 a.m., Monroe: SRFR units with Snohomish County Fire District 5 responded to a report of a brush fire in heavy timber in Monroe near Highway 2. Responders arrived to find a 20' X 20' brush fire 50 feet from the Burlington Northern rail line. Highway 2 was shut down for firefighting operations. The fire was successfully extinguished with no injuries to civilians or responders. The cause of the fire is being investigated by the Snohomish County Fire Marshal.

Gun Shot Victim

September 19, 2022, West Battalion: SRFR units responded with South County Fire to a report of a shooting with Washington State Patrol on location. Responders staged while the scene was being secured by police. Once cleared, responders assisted an adult male who had multiple gunshot wounds to his chest/shoulder area. The patient was transported to Providence Medical Center in Everett.



Brush Fire

September 19, 2022, Monroe: SRFR units responded to a large, fast moving, brush fire approximately seven acres in size behind Walmart. This is a known area with multiple homeless camps and lots of debris. The crews did an excellent job with an aggressive fire attack on two separate flanks.

Responders arrived to find a 50' x 50' fast moving brush fire and then established Galaxy Command. The fire was just east of Galaxy Road and north of Walmart and was moving rapidly up the hill to the north and the east towards the gravel road. There was a significant wind out of the west that was pushing the fire to the east towards Chain Lake Road. The fire was eventually estimated at seven acres. There were no injuries to civilians or responders. The fire is being investigated by the Snohomish County Fire Marshal. The cause of the fire is undetermined. Twenty-five units responded to the fire. Special thanks to assisting agencies; Washington State Department of Natural Resources, Snohomish County Fire District 5, Snohomish County Fire District 4, Snohomish County Fire Marshal, and Monroe Police.

Emergency Medical Services

SRFR Student Paramedics

Interfacility Transport

Units from East Battalion assisted in the transport of a patient from Evergreen Health Monroe to a Seattle hospital. Evergreen Health requested SRFR's Lucas Devise and transport capabilities to transfer a patient to the Seattle location. SRFR appreciates assisting regional partners with our highly trained personnel and advanced equipment.

Ultrasound Diagnostics

SRFR received an ultrasound device and are working with area physicians to provide our paramedics with the necessary training, so we are able to utilize the device to assist patients. Implementing this state-of-the-art technology will improve our diagnostic capabilities in a continuous effort to deliver the best patient care.

Training & Safety

Acting Captain Brian Kees

The Training/Health and Safety Division welcomed Acting Captain Brian Kees to the team. We are excited for his energy and contribution going forward. He will be primarily focused on supporting the training needs of the District.



Fourth Quarter Training

Fourth quarter training has been posted on Target Solutions. The Engine Committee will offer hands on training with the new 2.25” hose to demonstrate our expanded operability.

Annual Physicals

Annual Physicals were conducted via our mobile health partner Professional Health Services (PHS). The PHS physicals offer a full physical, comprehensive lab, and a personal wellness profile for each participant. These components are part of the District’s Wellness Initiative along with the Peer Fitness & Peer Support Teams.

Snohomish County Fire Training Academy (SCFTA)

The Snohomish County Fire Training Academy (SCFTA) Class 22-02 has completed the engine curriculum and is now moving on to the truck curriculum starting with ground ladders. The recruits and company officers are working hard and progressing well through the process. We currently have 13 recruits in the academy.

Live Fire Training

Annual live fire training has been scheduled for December. This planning process was delayed due to limited facilities that can support this training. Thank you to Snohomish County Fire District 26 for partnering with SRFR for the use of their facility.

Driver Operator Promotional Exam

The Driver Operator promotional exam is in process with the candidates having already completed the written test and the hands-on practical components. The oral interview is the last step in the testing process. It was noted that candidates have come to the process well prepared and displayed a high level of competency.
