#### Memorial Service for WSP Trooper Christopher Gadd

On March 12th, at the Angel of the Winds Arena in Everett, SRFR Honor Guard members and SRFR Pipes and Drums members participated in the memorial for WSP Trooper Christopher Gadd. SRFR staff members were also in attendance.

#### Significant Alarms

#### **Residential Fire Lake Stevens**

At 8:35 a.m. on February 16th, SRFR units responded to a confirmed residential fire at the 10300 block of 7th Place SE in Lake Stevens. E82 arrived and reported a fire in an attached garage. E82



stretched a line for fire control. E83 arrived and supplied E82 with water and searched the house. E83's crew found a victim asleep in their bed. The victim was safely removed from the residence. Firefighters quickly controlled the fire and contained it to the area of origin. The fire is under investigation by the Snohomish County Fire Marshal's Office.

### **Residential Fire Monroe**

SRFR units were dispatched to a residential fire in Monroe. B31 and E31 arrived at a two-story residence with smoke showing from the garage (garage door closed) but no active fire. The crews found one patient with extensive burns to torso on the front steps of the residence. E31's firefighter initiated patient care while E31's officer checked the interior for extension and then pulled an attack line for fire control. The crews found no fire had extended from the garage, but the house was filled with heavy smoke. E32 arrived and assisted with water supply, fire control, and patient care. E41 assisted with opening the garage with E31 utilizing less than 100 gallons of water to extinguish a sofa fire in the garage. B71 and B43 assisted B31. MSO71 arrived and was assigned Medical Group with M82, M42, and A51. E31 completed a primary search of floors 1 and 2 with nothing found. E41 with a secondary and nothing found.

M82 with additional manpower transported the burn patient to Harborview Medical Center.

Follow up: The patient suffered significant burns and has had several surgeries and is currently in a coma.

#### **Residential Fire**

E72, M72, E73, B71, MSO71, L71, E77, KCA 145, and E76 responded to a Fire Residential Confirmed, with reports of the resident screaming "My house is burning down and my bedroom is on fire!" B31 joined the response, and a second medic unit was requested which added M13.

E72 arrived and found a small one-story house with smoke showing from the open front door and eaves. The smoke was mid-wall inside Unit 4, and the seat of the fire was in the C-side bedroom. B71 noted the same observations and updated the building type to a 5 unit 1-story apartment complex. The fire was confined by E72's fire attack to the room of origin but the apartment unit had smoke damage throughout. Overhaul showed no extension to the attic or exposures. Additional crews performed a search of the residence, with nothing found. B71 coordinated with the Red Cross to provide the occupants of the units with housing.

### **Emergency Medical Services**

#### Active Shooter Class

SRFR sent six members to an Active Shooter – Advance Class. The class was approved by FEMA and focused on incident management in large scale incidents. Thanks to all who attended the three-day class.



#### **New Medications**

Nitroglycerin Infusions and Tranexamic Acid (TXA) have been purchased for familiarization, training, and implementation.

- Nitroglycerin infusions will be administered for patients with heart failure. This medication decreases the work of the heart and will help these patients breathe better. (Training has begun with this medication.)
- TXA is a medication which benefits trauma patients who are at risk of life-threatening hemorrhage. TXA has now arrived with training scheduled to begin in April.

### **Guest Speaker BC Curt Isakson**

During the week of March 6th, SRFR brought in a professional speaker, Curt Isakson, to discuss expectations, mindset, family, love of the job, and fireground tactics. Curt Isakson is currently a Battalion Chief for Escambia County Fire Rescue in Florida and he is a nationally known professional speaker, motivator, and educator. SRFR was able to share this great experience with many surrounding agencies. We thank Chief Isakson for his passion for the job and for challenging our minds.

### Block 2 Training in Snohomish

Block 2 Training in Snohomish at the Pine Avenue property was very successful, and crews have reported how valuable it has been. Crews trained on oriented search, VES, and window cut outs/window to door conversion. Snohomish Fire District 4 has provided SRFR and South County Fire a great opportunity to train in real houses. SFD 4, SRFR, and South County Fire will start Block 3 training on March 12th and Live Fire training on April 9th.

#### **Rx Safety Glasses**

Health and Safety is working on a plan to reintroduce Rx safety glasses to those who need corrective lenses. For those who wear corrective lenses, you will be able to take your Rx to Monroe Vision Clinic and get your choice of 9 styles of black safety glasses frames to choose from. Members interested in this program will need to get approval through their supervisor.
