Significant Alarms

Ammonia Chemical Leak

On December 13th, Engine 82 (E82) and HazMat 72 responded to an ammonia leak at Pacific Seafood in Mukilteo, which quickly escalated from a first to a third alarm response. A shelter-in-place order was issued within a 500-foot radius of the leak. SRFR crews, along with South County, Everett, Marysville, and Mukilteo fire departments, worked together to isolate the ammonia tanks. After six hours of coordinated efforts, the leak was contained, preventing a larger hazard, and ensuring the safety of personnel and the community.





RV Fire

On December 14th, East Battalion crews responded to an RV fire caused by a propane leak during a repair attempt. Engine 32 (E32) arrived first and quickly controlled the fire, preventing it from spreading to nearby vehicles, trailers, and debris. Crews discovered a damaged valve on the propane tank fueling the refrigerator, which crews moved to a safe location, dissipating the gas, and removing the hazard. The RV owner, with minor injuries, declined further medical care and chose to seek treatment independently. Thanks to the swift actions of E32 and E31, the fire was contained, exposure risks managed, and the individual treated.
