#### **CHIEF'S REPORT**

As presented. Chief O'Brien commented that last weekend Snohomish Regional Fire & Rescue and South County Fire partnered to provide a Future Women in Fire Workshop. He thanked Jessica Hanna as our lead coordinator as well as our support team and instructors including Shanell Rasmussen, Julia Thomas, Jordan Noto, Dr. Brooke Lundquist, Peter Mongillo and Kaitlin King. He also thanked everyone for their hard work.

#### **COMMISSIONER REPORTS**

Capital Facilities – Commissioner Schaub commented that they reviewed the Station 83 progress and RAB for additional costs, the Station 31 project proposal, the Stations 32 & 81 updates, and the Station 72 update with crews back in the station.

Finance Committee – Chairman Elmore commented that they met earlier this afternoon and discussed the revision to the last PERS Resolution regarding post-employment medical. They also had a presentation regarding salary surveys, a presentation regarding the fire benefit charge, and they discussed the Station 83 RAB change orders and the Station 31 Shop Remodel.

Sno911 - Commissioner Waugh commented that they went through a Regional Resiliency Test, and practiced taking over another agency's dispatch so they can continue to work if they were to get diverted



due to an emergency. He also mentioned their radio replacement project will be on time, switching to a digital system in early 2025.

#### **OLD BUSINESS**

#### Discussion

Continuous Improvement: Hiring Committee

Chief O'Brien commented that we had a successful hiring process for entry level firefighters, and we have asked Battalion Chief Hammeren and Battalion Chief Basta to share about the process.

Battalion Chief Basta commented that a few months ago we formed the Hiring Committee to improve transparency, ensure that we are hiring the best candidate for the job and improve candidate retention. We asked our firefighters for their input; and as a team we created questions. We are hiring so many people without experience who don't really know what is different about our agency. We decided to set up a special Open House for those candidates who were moving on to the Chief's interview. The goal was to make the Open House fun for the candidates and their families; and show them what is so special about SRFR. We had a BBQ, we had Union Reps available, HR, Water Rescue Team, and the Chief was there to answer questions. He thanked HR for their cookie decorating station for the kiddos; and mentioned that many of those candidates were impressed with the Open House. Additionally, after each round of interviews, the panel members came back together to discuss what went well and what could be improved upon, to help finetune the process. Lastly, we requested that we have two Battalion Chiefs included in the Chief's interviews.



Battalion Chief Hammermen commented that he was in on the Round 1 Interview which was like a rapid-fire interview. We interviewed 130 candidates with very simple basic questions; and for the first time we gave them the questions prior to the interview. The next round was an Oral Board with more in-depth questions with the top 60 candidates; and then the top 30 candidates moved on to Chief's Interview and they were invited to the Open House. Battalion Chief Hammermen commented that this process allowed him to interact with the candidates three different times, with time to process everything in between the series of interviews. This process is going to add to our quality.

Commissioner Schaub asked if most of the candidates are looking to stay close to their home or are they interested in relocating. Battalion Chief Hammermen commented multiple candidates mentioned that SRFR wasn't their first choice, but after the Open House they were reconsidering. Most will probably stay closer to their residence; recruitment basically comes down to opportunity and our contract. The Hiring Committee is a lot of extra effort, but it is a huge priority for us to recruit and retain high quality people, and we are doing our due diligence.

Chief O'Brien commented that we made a mistake by including dental for our retirees in the resolution, unfortunately our dental plan does not allow for that type of coverage. After much thought and discussion, we decided to add \$75 per month toward the retiree's VEBA in lieu of the dental.

Deputy Chief Rasmussen introduced the Station 31 shop contract with GenCap Construction which covers the base bid price, bid alt 1, bid alt 2, and the do not exceed 10% of package proposal. This has been discussed in both the Capital Facilities and Finance Committees.

# Station 83 Change Orders

Chief O'Brien commented that this was supposed to be completed in June, and there have been quite a few challenges. Our goal is to get our crew back in the station as soon as possible. The best-case scenario would be the end of August. We are requesting this as an action item today because we want to take care of this as soon as possible.

Deputy Chief Rasmussen commented that this has been reviewed in both the Capital Facilities and Finance Committees. This is increasing the project costs of Station 83 to cover the 10% do not exceed amount, the siding change order, the water damage change order, and the new fire alarm panel. The new gross maximum price (GMP) is requested to be \$1,438,946 which is an increase of \$188,946 over the original request.

## Motion to approve the Station 83 Change Orders as submitted.

Chairman Elmore thanked everyone for their work.

Commissioner Schaub shared his concern regarding fireworks and noted that the majority of fires break out in Washington state on July 4th, and there is data to support this.
